Council Meeting Minutes
Monday, February 6, 2023 5:00 P.M.

1) There being a quorum present, Mayor Tubbs called to order the regular meeting of the Town of Killen Council Meeting at 5:02 p.m. on Monday, February 6, 2023 at the Killen Town Hall.
